DEPARTMENT HEAD YEAR END REPORTS

1. Building, Planning, Zoning: Warren Tutt

Casa Vallarta restaurant opened with positive reviews; Kingston Commons sanitary infrastructure nearing its end; Northeast Center int/ext. work; Spectrum Mobile open; Central Hudson facility started this month; Ten Broeck Commons interior renovations; Ulster Dialysis possible opening in four weeks; major overhaul will be at Five Guys; Burlington moving to Barnes & Noble; in 2020, issued 389 permits with construction costs approx. \$63M; collected in excess of \$425,000.

2. Assessor: Miranda Bernholz

Last year reorganized office files and caught up on property inspections from prior six month; got new inventory on the roll. Also had first virtual "Grievance Day" which went smoothly. Summer reviewed 15 boxes of legal documents and found new system to file the larger commercial properties. Mary started a border project, reviewing every property on the border of the Town of Ulster to make sure they are properly included in the Town of Ulster roll. She found 50 properties to over with neighboring towns to make sure assessments are distributed correctly. Currently doing major assessment changes for newer construction builds and larger additions.

3. Highway Department: Frank Petramale

We all managed well even having to deal with Covid in 2020. Fewer summer employees. Able to maintain properties as usual and put down about 11,000 ton of blacktop. Very productive year. Appreciates all work by his guys. Took care of drainage issues mainly in Lakeview and Lucas Ave areas. Assisted sewer department in Spring Lake Phases 1 and some of Phase 2. Appreciates support from town board and supervisor and all support from all other departments as well as we work together.

Supervisor: Note that there is a motion on tonight for the highway department to buy s some trucks.

4. Police Department: Kyle Berardi

Policing and police reform during Covid continued. Some department members were positive and are back up and well. Calls for service are up from 2019 2.6%; Two percent increase in detective cases; increase index crime reports; 32 % decrease in Part 1 crimes (murder, rape, larceny, robbery, etc.); 37% decrease in Part 2 crimes (arson, kidnapping, sex offenses, etc.). Larceny decreased dramatically. Covid contributed to decreases. Police Reform Committee formed, and first town hall public meeting was last night and went well. Committee members very committed. We do all of this with assistance of other departments and we can't not notice the hard work and general comradery between department heads and support of town board and supervisor.

Supervisor: re calls for service statistics, would they include responses on pause violations?

Berardi: Yes, those are all calls for service.

Supervisor: The increase may be from increased enforcement on Covid-related rules and not necessarily indicative of a declining public safety environment in our community?

Berardi: We responded to 3-4 pause complaints per week, it was only a slight increase.

5. Town Clerk/Tax Collector: Suzanne Reavy

2020 – Town offices closed due to Covid from March 30 – July 13, and again December 1 – present. Town Clerk operating since March closure with just deputy and town clerk. Issued \$6,800 in refunds of pavilion and boat launch cancellations. No summer camp in 2020, which fees generally average \$60,000. Despite this, fees were up \$15,000 this year compared to 2019. Town Board held 34 meetings, 20 virtual. Many had to learn virtual meetings. Meetings held live on Facebook. Developed a YouTube channel. Currently working on tax collection, and to date we are \$2M ahead of last year at this time, collected approximately \$4.6M.

Supervisor: Recalling a recent conversation, how many actions made by the town board in 2020?

Reavy: The town board voted on 333 motions and/or resolutions in 2020.

6. Wastewater Department: Vincent Maggiore

Busy year in 2020. Thanks all of his staff, has been a rough year dealing with Covid and projects. Plant performed well. Scheduled year for pole effluent toxicity testing, which happens every five years. We passed all four quarters – very big deal. We did work to remove I & I (inflow and infiltration) which entails monitoring, surveying and repairing. Added new tools to these repairs fiberglass spot repairs - training on staff. We completed Spring Lake Sewer project special thanks to highway department – low pressure sewer system, thousands of feet. Now about six residents up and running. Hopefully we have an extension until the end of June for residents to connect. Whittier and Washington Avenue Sewer no problems to report.

7. Water Department: John Rose

Everyone is healthy. 448 service calls; 496 mark outs; 8 water breaks; All NYS testing completed in all seven districts with no violations. Every three years, all seven districts inspected by UC Health Department and this year 6/7 districts had no violations. Ulster District had a minor violation which was a screen on an overflow pipe. Day to day operations are going well.

Supervisor: Thanks department heads for working in very adverse conditions. Convey the same to the town employees the appreciation of the town board. At this time, no town employees or officials under quarantine. We have been aggressive in staying on top of symptoms and quick to have employees go home, monitor symptoms, for the benefit of fellow employees.
