PARK RULES

- 1) BEFORE MEMORIAL DAY THE PARK IS OPEN FROM 8:00 AM TO 7:00 PM. FROM MEMORIAL DAY TO LABOR DAY THE PARK IS OPEN FROM 8:00 AM TO 9:00 PM. AFTER LABOR DAY THE PARK CLOSES AT 7:00 PM.
- 2) PARK BATHROOMS WILL LOCK 15 MINUTES PRIOR TO CLOSING OF PARK.
- 3) NO SWIMMING ALLOWED.
- 4) NO ANIMALS ALLOWED.
- 5) NO COOKING OR FIRES ALLOWED UNDER THE PAVILIONS.
- 6) REFUSE MUST BE PUT INTO PROPER CONTAINERS AND THE AREAS MUST BE CLEANED BEFORE LEAVING. TABLES MUST BE RETURNED TO THEIR ORIGINAL POSITION.
- 7) USE OF THE ATHLETIC FIELDS ARE LIMITED TO TWO HOURS.
- 8) RIDING OF MOTORCYCLES OR MOTORIZED BIKES AROUND THE PARK GROUNDS, OTHER THAN ON ROADWAYS, IS STRICTLY PROHIBITED.
- 9) THE USE OF FIREWORKS IS STRICTLY PROHIBITED.
- 10) THE SERVING OF FOOD TO THE PUBLIC – FREE OR AT A COST – REQUIRES A PERMIT FROM THE ULSTER COUNTY DEPARTMENT OF HEALTH.

***** ALCOHOLIC BEVERAGES ARE ALLOWED PROVIDED THAT SUCH A GROUP HAS PROCURED INSURANCE COVERAGE LISTING THE TOWN OF ULSTER AS AN ADDITIONAL INSURED IN AN AMOUNT OF NOT LESS THAN ONE MILLION (\$1,000,000.00) AND FILED WITH THE TOWN CLERK THE DAY PERMIT IS PAID FOR.**
